SUBJECT: PLANNING COMMISSION REPORT

1) Nutt reported the Planning Commission's next meeting is May 15, 2017.

SUBJECT: NEW BUSINESS

- 1) Nutt made motion for a Construction Board of Appeals to be established for the township, seconded by Wilburn; Motion accepted by roll call vote: Ayes: Knapp, Wilburn, Hogan, Spoelman, Nutt (5)
- 2) Spoelman discussed that new laws are coming in December 2017 regarding medical marihuana, and that the township will send it's ordinance to the lawyer to make amendments so that it will comply.
- 3) Nutt made motion to accept performance/indemnification resolution for the township to have brining done this year by Michigan Chloride Sales LLC, seconded by Wilburn and passed by roll call vote: Ayes: Wilburn, Hogan, Spoelman, Knapp, Nutt (5)
- 4) Spoelman made motion to continue to have Ron's Lawn Service do the lawn care this season, at the same rate of \$515.00/month, seconded by Knapp. Ayes: (5)

SUBJECT: PUBLIC COMMENT

- 1) Residents inquired about a possible pig farm that may be going up across the road from their home, and what criteria has to be met before it can be built.
- 2) John Bumstead, candidate for state senate, discussed his running for the seat.
- 3) Gary Foster stated that election advertising bills will be the responsibility of the townships now and not the county. Also, there will be a hazardous waste disposal held by the city of Muskegon on 22 April 2017. Lastly, at the public works meeting, a vote was taken to pay for a water study, and should be completed in 2 years. A survey is being conducted to determine which route is more efficient to run the study.

SUBJECT: BOARD MEMBER COMMENTS

- 1) Discussion by Spoelman that the township will no longer be using the retirement services of Joe Conn, and go directly through Symetra.
- 2) Wilburn commented that the condition of Laketon Avenue, between Ravenna Road and Slocum Road is very poor. Nutt will be meeting with MCRC and will bring the subject up with them to discuss solutions to fixing the road.
- 3) Spoelman also notes that there will be a scrap tire event held this year at Egelston Township Hall at 5248 Apple Avenue, on June 24, 2017 from 9 a.m. until 2 p.m. This may be the last year for the event, unless another board member would like to take it over.
