The Moorland Township Board of Review will hear appeals by appointment. Taxpayers should call (231) 853-2015 during normal business hours to schedule an appointment. (Voice Messages will be returned) The Board of Review will meet at the times listed above to hear appeals by property owners or their representatives. The owner's representative must present a letter of authorization signed by the property owner in order to be heard. Letter appeals are accepted in lieu of a personal appearance and must be received no later than March 14, 2017 at 4:00 p.m. (postmarks are not acceptable). Taxpayers are welcome to contact the Assessing office prior to the Board or Review dates to discuss their 2016 assessed or taxable values at (231) 799-6806.
